Risk assessment of a sociotechnical system identifies hazards that can result in human, material or environmental losses, the likelihood of such hazardous events, and their consequences. Traditional methods rely on reliability-based techniques to identify the potential for an accident before it occurs. However, such approaches are limited in their ability to account for social and organizational factors, interactions between system components with feedback, the adaptation of an organization to a constantly changing environment, and human behaviour. This project-based course combines theory and practice to present a system-theoretic approach to risk assessment.

| <p>Changes in technology Changes in technology since the 1950s produced new hazards and led to fundamental changes in the etiology of accidents that mandate different approaches to explain accidents.</p> |
| <p>Traditional accident and risk analysis A review of traditional accident causation models and related approaches used in accident and risk analysis. Such approaches assume a critical chain of events and often rely on probability theory to determine the likelihood of physical component or human failures.</p> |
| <p>Systems thinking A discussion of the general framework of system engineering used to analyze accidents in modern complex systems. Introduces the notion of safety as a control problem.</p> |
| <p>Accident causal analysis using systems theory A study of the System-Theoretic Accident Model and Processes (STAMP) model of accident causation and its application using the 2004 Vioxx prescription drug recall as an example.</p> |
| <p>System dynamics System dynamics is used to analyze a sociotechnical system and understand how it evolves from a safe state to an unsafe one, potentially resulting in an accident or disaster.</p> |
| <p>System dynamics simulation Overview of simulation with a visual program language like Vensim, Anylogic or Stella and its use in implementing a STAMP dynamic model.</p> |
| <p>System-theoretic process analysis (STPA) STPA is a hazard analysis method based on the STAMP model of accident causation. This method is demonstrated by using an example from aviation.</p> |

The how-tos of STPA

Guidance is provided on specifying or forming system goals, loss events, hazards, safety constraints, the safety control structure, inadequate control actions, context, and causality.

STPA example

Demonstration of the application of STPA to a train control system using the IEEE Standard 1474 for the Communication Based Train Control (CBTC) system design.

The role of humans

A discussion of how to incorporate the role of humans in complex automated systems using STPA, identify causal scenarios related to human-machine interactions, and understand the operational context of unsafe operator action. Automated Parking Assist is an example.

Team Project (50% of course grade)

The applicability of System-Theoretic Process Analysis (STPA) to prevent and mitigate natural disasters will be explored by student teams as a collaborative class-wide team project using Hurricane Katrina as an example. The instructor will guide this activity, and the students will be expected to present and discuss intermediate progress in the class.

Term Papers (30% of course grade)

Two term papers will focus on the meaning of risk and the relevance of social (i.e., psychological, organizational, and political) factors to understanding the sources of failure contributing to major disasters and how such insight can inform risk assessment and prevention.

Topic Reviews (20% of course grade)

The reviews will be assignments discussing the topics covered in class.

Simulation (optional 5% bonus)

A system dynamics model of Jay Forrester's World Dynamics Model can be implemented for a bonus grade using Vensim programming. This classic reference is available online:
